# **Description**

The UT54ACS02 and the UT54ACTS02 are quadruple, two-input NOR gates. The circuits perform the Boolean functions  $Y = \overline{A} + \overline{B}$  or  $Y = \overline{A}.\overline{B}$  in positive logic.


The devices are characterized over full military temperature range of -55°C to +125°C.




Figure 1: 14-Pin DIP
Top View







Figure 2: 14-Lead Flatpack Top View






